# 1 INTRODUCTION

#### 1.1 Purpose of the addendum report

This addendum report has been compiled following the public review period of the scoping report for the proposed Ongombo Copper Project on exclusive prospecting licence 5772 (EPL 5772) within mining licence 240 (ML 240), Khomas Region, Namibia. Proposed by the Proponent Shali Group Holdings (Pty) Ltd.

The scoping study was completed for the Project and undertaken in accordance with the requirements of the Environmental Management Act, 2007 (Act No. 7 of 2007) and the Environmental Impact Assessment Regulation, 2007 (No. 30 of 2011) gazetted under the Environmental Management Act (EMA), 2007 (Act No. 7 of 2007).

Environmental Compliance Consultancy (ECC) prepared the scoping report, which was provided to the public for review for 7 days from 10 to 17 November 2022.

This addendum compiles all comments received during the public review period; presents the responses from ECC as the appointed environmental assessment practitioner (EAP) for the Project and the Proponent; and signposts where further information will be provided in the ESIA report.

## 2 SUMMARY OF COMMENTS FROM I&APS

#### 2.1 Introduction

The scoping report was formally submitted to the relevant competent authority (Ministry of Mines and Energy (MME)) and Interested and Affected Parties (I&APs) on Thursday 10 November 2022. A copy was also submitted to the line Ministry, the Ministry of Environment, Forestry and Tourism (MEFT), on the 10 November 2022 for public and stakeholder comment.

Comments received were collated in a register that is presented in Table 2. Each comment has been responded to, and where they were deemed to be material to the decision making or enhance the ESIA process, amendments were made to the scoping report.

The final scoping report with this addendum will be submitted to the competent authority, MEFT, stakeholders and I&APS.

#### 2.2 Key feedback on issues of concern

The scoping report was provided to all I&APs, identified stakeholders, and made publicly available on ECC's website to solicit comments, feedback, and allow genuine participation in the scoping phase of the ESIA process.

Comments were received from one I&AP during the review process, from a neighbouring farm owner. Further information has been provided in this addendum report to address the area of concern or to answer the question presented.

The key areas raised from the review can be summarised in the following categories:

**Traffic management and road maintenance:** Concerns were raised regarding the access road to the Ongombo Copper Project, that there will be an increase in traffic, additional road maintenance required and potentially increase in crime.

 The traffic management will be assessed during the environmental and social impact assessment and mitigation measures incorporated into the environmental management plan.
